**Waiver:**

As a condition of use of the ski area and other facilities, the Ticket Holder assumes all risk of personal injury, death or property loss resulting from any cause whatsoever including but not limited to: the risks, dangers and hazards of skiing, snowboarding, cycling, hiking and all other recreational activities; collision with natural or man-made objects or with skiers, snowboarders or other persons; travel within or beyond the ski area boundaries; or negligence, breach of contract, or breach of statutory duty of care on the part of the Township of Algonquin Highlands Ski Area Operator and its directors, officers, employees, instructors, volunteers, agents, independent contractors, subcontractors, representatives, sponsors, successors and assigns (hereinafter collectively referred to as the "Ski Area Operator"). The Ticket Holder agrees that the Ski Area Operator shall not be liable for any such personal injury, death, or property loss and releases the Ski Area Operator and waives all claims with respect thereto. The Ticket Holder agrees that any litigation involving the Ski Area Operator shall be brought solely within the Province of Ontario. The Ticket Holder further agrees that these conditions and any rights, duties and obligations as between the Ski Area Operator and the Ticket Holder shall be governed by and interpreted solely in accordance with the laws of the Province of Ontario and no other jurisdiction.

**The Ski Area Operator's liability is excluded by these conditions.**
