WINTER IN ALGONQUIN HIGHLANDS

Summer isn't when all the fun happens here in Algonquin Highlands, winter also has lots to offer! We have two lit skating rinks open to the public all winter long (Stanhope Gardens and Dorset Ice Palace - open as long as ice and weather conditions permit). There are 22km of groomed cross-country ski trails and 38km of trails for snowshoeing in and around the Frost Centre. The Dorset Recreation Centre has a fully "stocked" gym, including squash courts, elliptical, rower, treadmills, universal gym, bikes, bags and benches! There are change rooms with showers and lockers.

Recreation programs continue all winter long at the Dorset Recreation Centre and the Stanhope and Oxtongue Community Centres. And if you want to do your own thing, there is a gymnasium for basketball, pickleball, walking, ping pong and anything else you can dream up. When you are just looking for a place to get together with friends or family, there are meeting rooms, a hall and commercial kitchens available for rent. ax Information

- Tax bills are mailed twice a year in February and June, with two installments on each bill.
- Payments can be made by cheque, cash, debit, telephone/internet banking or by pre-authorized payment on due dates. A drop box is available at the main office.
- Applications for our Pre-Authorized Payment Plan are available on our website or at the Municipal Office for properties that are NOT in arrears.
- Penalty/Interest of 1 1/4% is added at the beginning of each month on past due amounts. Please ensure payments are received by the Township on or before the stated due dates to avoid penalty. The Township is not responsible for delays in payment caused by your bank or Canada Post.
- If your home is newly constructed or if any new construction, renovation or alteration has occurred on property that you own, your property may not be fully assessed. A "Supplementary Tax Notice" is issued once the additional assessed value of your property has been determined by MPAC. This is in addition to the other tax bills received during the year.



MUNICIPAL PROPERTY ASSESSMENT CORPORATION

Updated property values coming this year

Every four years, the Municipal Property Assessment Corporation (MPAC) sends out a Property Assessment Notice to all Ontario property owners.

Property Assessment Notices will be mailed from May to September, and will reflect the updated value of your property as of January 1, 2019. Municipalities will use your assessment to calculate your 2021-2024

WSP will forward time sensitive information to all property owners scheduled to be inspected in 2020.

indicated on the letter.

Saturday, May 30, 2020 10 am at the Dorset Recreation Centre. WSP will be on hand with a presentation and to answer questions.

Please note: If you do not respond to WSP's request to book your inspection, you will be assigned a mandatory inspection date. If you are not prepared or not present for the inspection, you will be responsible to pay a fee of \$179.11 for a missed inspection. You will then be required to pay an <u>additional</u> \$179.11 once the inspection has been completed.

If you have a metal septic tank your system will be considered unsafe and require replacement, please contact the Township immediately to avoid a charge of \$179.11. You will be required to obtain a septic permit to replace the current metal tank, this may also require the septic bed to be replaced.

Zoning By-Law Review

2018

Algonquin Highlands has started a review of the Zoning By-law (ZBL). The ZBL review process will implement the policies of the recently adopted Official Plan Amendment. Topics to be discussed during the ZBL review will include but not be limited to cannabis cultivation/retail, redevelopment of legal non-complying structures, minimum dwelling size, short term rentals and Boathouse regulations.

The ZBL review process will provide for community discussion about the development of Algonquin Highlands. Community engagement and participation in the process is paramount to the success of this project. Public meeting dates to be announced.

ENVIRONMENT AND STEWARDSHIP COMMITTEE

This Committee has developed three areas on which to focus in 2020:

- Reducing use of single use plastics
- Developing and protecting pollinator habitat
- Encouraging home composting

The Committee is developing public education programs that show practical ways in which these goals can be achieved simply and effectively. They will be showing easy alternatives to single use plastics, sharing information on the very significant role pollinators such as bees and butterflies play in preserving our environment and simple ways in which their environment can be protected. They will share waste diversion techniques that can help to increase landfill site lifespans and safe practices for composting in "bear country". Watch for displays and activities put on by this active Committee at Community events this year.
