20	Owner fails to maintain surface conditions of vacant land	6.2	\$150.00
21	Owner leave/store vehicle/part of vehicle/machinery/trailer/boat on vacant land where prohibited	6.3	\$150.00
22	Owner/occupant fail to comply with an order	8.5	\$300.00
23	Obstruct officer/employee/agent performing duty under by-law	10.1	\$300.00
